APPENDIX TO NOTICE OF ANNUAL GENERAL MEETING

Appendix - Special Resolutions

1. Clause 10.1 of the Constitution be amended to read as follows:

"The members of AAFC shall consist of Eligible Clubs which apply for and are admitted to membership by the Directors."

2. Clause 48 of the Constitution be amended by adding the following defined term:

"Eligible Clubs" means clubs which participate in premier competitions which are administered by Football Australia or Member Federations, including:

- a) National Premier Leagues ("NPL"); and
- b) other premier competitions for women and/or men where the criteria required for clubs to participate is similar to that which applies to the NPL in that State or region.

3. Clause 10.2 of the constitution to read as follows:

"Any club which ceases to be an Eligible Club, as provided in Clause 48, shall cease to be a member and shall be entitled to re-apply for admission as a member upon again becoming an Eligible Club"

4. Clause 15.1 of the constitution to be amended as follows:

Reference to "50%" shall be replaced with "33%".

5. Clause 24 shall be amended to read as follows:

5.1 Clause 24.1:

"There must not be less than six Directors and not more than 12 Directors comprised as follows:

- a) Not more than 10 Directors are to be elected by the members ("elected Directors");
- b) There are not more appointed Directors than elected Directors;
- c) At all times from I January 2022, not less than 40% of the Directors shall be female and not less than 40% of the Directors shall be male"

5.2 Clause 24.2:

"Members from each state or federation shall elect at least one and not more than two Directors to the Board from time to time so that at no time shall a state or federation be represented by more than two elected Directors on the Board and not be represented by any Directors. Nothing in this clause shall prevent the Board appointing a Director from a state or federation which is represented by two elected Members"
