# AAFC Chairman's Address:

The Chairman reflected on the continuation of football during a major pandemic. 2020 has certainly been a very difficult year for all involved in the sport.

The Chairman stated he as proud to state to the Members that the Board had upheld the core purpose of the AAFC i.e. to act primarily to provide a measured, consultative and professional voice on behalf of our Members Clubs so as to engage with all the football stakeholders to find solutions that will help benefit football.

Specifically, the Chairman discussed the extensive work done and progress made with respect to:

#### I. COVID-19 pandemic

AAFC was active in supporting clubs deal initially with the lockdown of the sport (and life in general) and then proposals from various state federations to resume football around July/August 2020.

#### 2. National Second Division

The Chairman advised work continued on the quest to establish a NSD, despite the challenges posed by the pandemic. form initial meetings in early 2020 with the then new FFA CEO, through to the establishment of the NSD Partner Group whose work will be reflected in a Progress report to be issued in the near future.

### 3. NPL Review

The Chairman reminded Members of the comprehensive report developed by AAFC in 2018 "5 Years of the NPL: A Clubs' Perspective: A Report by the AAFC on behalf of NPL Clubs".

The Chairman was please to advise that after consultations with FFA, the FFA has adopted the principal recommendation of the AAFC to conduct a National Review of the NPL.
