Item 2

Interim Chairman Tom Kalas provided following report:

"Welcome all members.

We're using a conference call system so as not to burden clubs with more expense.

Think about what we have all accomplished together since our first meeting on the 20th March in Melbourne.

We first set up a Steering Committee to introduce the aims and bring the nation of clubs together.

We set up a National Delegates group from all states to structure a Constitution and map out the next process. There, we also agreed on the key objectives we would strive for.

Then, we had all members within the states get together and discuss which candidates they were comfortable in representing them on a national board. Clubs put away their onfield rivalries and agreed on candidates.

Then, no one challenged these candidates and no elections were required. Incredible ©

We have had big states agree to the principle of 1 vote per state, no matter how small the state, to create an organisation of equals. I thank all the clubs from the large states for their strategic vision.

We have had a strong and consistent message throughout this time in the media that focused on us being "measured, professional and consultative". This messaging was crucial to a new organisation, as initially most other stakeholders felt threatened.

And now because of our organisation we have had the football landscape change dramatically within the last 3 months. The FIFA head of Associations Luca Nicola has remarked, they've never seen anything like this occur globally, and all in 3 months.

Together we have done all this since March 20. So, congratulations to all of you.

Now how has the landscape changed?

Firstly

We have been in close communication with FIFA & the AFC.

They admire the speed and breadth of what we have done together. Our success & what we represent has encouraged FIFA to demand our inclusion in the Congress process.

In fact, FIFA is demanding that a wider cross section of the football family be included in the Congress. The Congress decides the FFA board members and strategic direction.

As you all know, the FFA has delayed several times the deadline for these reforms.

Tomorrow, 4th July, FIFA's Member Association Committee meets to decide on FFA's request to delay.

There is a significant chance that FIFA will refuse & instead intervene and remove the FFA board and management under section 8.2 of the FIFA Statutes.

Now you would all have noticed that late last week the A-League franchise association has escalated its dispute with the FFA & demanded a forensic audit of all its finances.

Furthermore, it appears that there's been a more serious escalation tonight between the 2 parties, but we best wait to hear it formally from their statements tomorrow.

The FFA's acceptance of the forced Congress changes demanded by FIFA (with the further pressure from the FFV due to their conditional support of the FFA) means that we are all looking at significant reforms in how the game is structured in Australia.

It's not just about a 2nd Div. It's more than that.

By linking the football tiers it promotes the expansion and upgrade of football facilities which in turn builds football culture which in turn brings commercial success. It will take 2-3 generations to build football culture.

There are no short cuts in building football culture. We've tried a shortcut with the A-League franchise model. And we are all seeing the repercussions of that flawed strategy.

If you recall on the 28th of Feb, the FFA announced that they were bringing in more consultants (this time Deloittes) to look at alternative financial modeling for the A-League & W-League. The privatised franchise model is obviously not working. Now we have the situation where the A-League clubs are fighting amongst themselves & trying to remove the FFA Board as well.

All the more reason why we need to exist, to be organised & try to protect the game by helping it migrate to a tried and tested international model.

Some clubs do not have the ambition yet for a 2nd division etc. But populations will not stay static, future committees and boards might decide they are ready and ambitious.

We need to migrate to an international recognised football structure to allow all clubs the option of advancement if they want it in the future.

We need to put the right structures and leave the right legacy for the committees/boards that come after us. We need to develop clubs first. Everything else flows from that.

Globally the game has grown because of those linkages it's the most important differentiator from all other codes. Look what's happening to Rugby Union & Cricket. Those codes have little or no linkages and they are starving their grassroots. Now it's impacting the top tier detrimentally.

By linking the football tiers is will accelerate an expansion of the football facilities footprint across Australia. Which over time will build football culture. Which then in turn promotes commercial success. There are no shortcuts.

Everyone is quickly realising that the AAFC manages/controls most of the significant football infrastructure in Aust.

We are by far one of the most important football stakeholders and the long-term growth of the game will come from your clubs.

Although we are all volunteers, we have conducted ourselves with incredible professionalism and above all great unity.

I commend you all."
